

## OFFICIAL SWEEPSTAKES RULES AND REGULATIONS

### NO PURCHASE NECESSARY.

**WHO CAN ENTER:** This Sweepstakes is open to all persons who are legal residents of the United States on January 1, 2022 12:00 a.m. CST (Central Standard Time) and who are invited to enter by Ipsos. This promotion is not open to the general public. Employees, officers, directors of Ipsos-Insight, LLC, (“**Ipsos**”), and Bridgestone Retail Operations, LLC (“**Bridgestone**”), their respective parent companies, subsidiaries, divisions and affiliated companies and advertising or promotional agencies, immediate family members and members of the same household of such employees/officers/directors are not eligible to participate in this Sweepstakes.

**HOW TO ENTER:** All entrants who are invited by Ipsos and/or Bridgestone to participate in this Sweepstakes and who have completed the survey at [www.firestonesurvey.com](http://www.firestonesurvey.com); [www.wheelworkssurvey.com](http://www.wheelworkssurvey.com); or [www.tiresplussurvey.com](http://www.tiresplussurvey.com) will receive one (1) entry. When responding to the survey, entrant must provide information that is true and correct to the best of his/her knowledge and belief or reflects his/her current honest opinion, as the case may be. Entrant further understands and agrees, upon request and without compensation, to respond to inquiries from Ipsos in the future to determine whether he/she still holds the opinions set forth in his/her survey responses.

Only one entry per person will be permitted, regardless of the website used to access the survey. Ipsos and Bridgestone are not responsible for lost, late, damaged, illegible/garbled, stolen, misdirected, misidentified, delayed, or incomplete entries, for any problems or technical or mechanical malfunction of any telephone systems, computer on-line systems, servers, access providers, computer equipment, software, failure of any entry (or set of survey responses) to be received by Ipsos or Bridgestone on
